

# The Reefer Sail Company Limited Website Terms

## 1. Terms of website use

- 1.1. This page (together with the documents referred to on it) tells you the terms of use on which you may make use of our website ([www.reefersails.com](http://www.reefersails.com)) (**our site**), whether as a guest or a registered user. Please read these terms of use carefully before you start to use the site. By using our site, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using our site.

## 2. Information about us

- 2.1. [www.reefersails.com](http://www.reefersails.com) is a site operated by The Reefer Sail Company Limited (we). We are registered in England and Wales under company number 06771116 and with our registered office at Timberly, South Street, Axminster, Devon EX13 5AD. Our main trading address is The Sail Loft, Heron House, Hawley Bottom, Axminster, Ex 13 7HR, United Kingdom.

## 3. Accessing our site

- 3.1. Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.
- 3.2. From time to time, we may restrict access to some parts of our site, or our entire site, to users who have registered with us.
- 3.3. If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any third party.
